Implementation of "Just-in-Time" fund release through e-Kuber

under SNA-SPARSH

The Government of India, Ministry of Finance, has implemented the "Just-in-Time" (JIT) fund release mechanism through the e-Kuber platform for the disbursement of Centrally Sponsored Schemes (CSS) under the SNA-SPARSH system. This initiative aims to ensure more effective cash management by enabling integrated fund flow from both the Centre and the State Consolidated Funds through a network linking State IFMS, PFMS, and the e-Kuber platform of the Reserve Bank of India (RBI).

Under this system, for all Centrally Sponsored Schemes (CSS), the concerned Ministry will issue a mother sanction in PFMS for each scheme, indicating the drawing limit and validity period. Consequently, all State Linked Schemes (SLS) are now mandated to open Drawing Accounts in the RBI.

Once the State Finance Department places the funds based on mother sanctioncomprising both the Central and State shares—the implementing department shall submit a fund release proposal to the Finance Department, along with necessary details for submission to Cyber Treasury. This proposal should be based on actual requirements and within the limits of the placed amount. The bills will then be consolidated, and an e-claim will be generated and forwarded to the RBI for direct disbursement into the final beneficiary's bank account via the e-Kuber platform. Since the system is developed to simultaneously debit from Government of India and State's Accounts and credit to beneficiary's account, any claim referred to Reserve Bank of India should invariably carry both Central and State's share to avoid erroneous/failed disbursement.

As Central Share is no longer routed through the State Consolidated Fund, clearance from the Planning & Transformation Department shall not be required for its release. However, State's Share allocation and release will continue to be routed through the Planning & Transformation Department.

This Office Memorandum is issued with the approval of the Competent Authority. All concerned departments are requested to take necessary action accordingly.
